In 1995 she left Hammonds to establish the highly successful specialist pensions practice, Anning Law. In 2009 she was joined by another pensions specialist, Kate Ive, and Pension Partners LLP was formed.

General Advisory

• Pauline advises employers and trustees on all aspects of occupational and personal pension schemes, including the impact of new legislation, regulatory changes, scheme governance, internal disputes, complaints to the Pensions Ombudsman and court applications. Pauline also provides pension support to the corporate finance departments of several large commercial firms. A summary of the work she undertakes is set out below.

Corporate Transactions

- Advice on the pensions issues on company share and asset sales, and management buy outs.
- Undertaking due diligence for corporate investors.
- Advice to corporates and financial backers of companies who wish to extract value from any given group of companies.



- Advice on the moral hazard provisions of the Pensions Act 2004, liaison with the Pensions Regulator and the submission of clearance applications.
- Advice on the Transfer of Undertakings (Protection of Employment) Regulations 2006, and the impact of Beckmann liabilities, including the implications of the Procter & Gamble case.

Regulatory and Statutory Compliance

Public Sector Work
